Call for Research Abstracts at the CSA 2025 Annual Meeting

April 4-6, 2025 | Disneyland Resort Hotel, Anaheim

The California Society of Anesthesiologists would like to invite you to participate in the annual Oral and Poster Presentation competition at the CSA Annual meeting, April 4-6, 2025, at the Disneyland Hotel in Anaheim.

The best 10 submissions will be chosen for oral abstract during a CME session. Those remaining will be invited to present their research as a poster, which will be judged and viewed separately from the Oral competition. The schedule of events pertaining to the poster and oral sessions are as follows:

- Friday evening/before 7:00 AM Saturday- posters provided at venue
- Saturday 7:00-8:00 AM Poster viewing and Judging
- Saturday Lunch- Poster Viewing and Judging
- Saturday 4:45-6:00 pm Oral Presentations Judging/Posters winners announced

The deadline for submission is Monday February 10, 2025 by midnight Pacific time.

The Annual Meeting's scientific committee will review your abstract submission and will notify you no later than March 7, 2025, of their decision. If your abstract has been selected as an oral presentation, then the date and time of your presentation will also be announced. Presenters will also be given discount registration information so they can register for the event (registration is not complimentary). Please see below for the Abstract Guidelines and Template.

The abstract presentations are an excellent opportunity for recent, up to date and relatively unknown research/points of view on health issues/case reports to be shared with fellow peers. The objective is hopefully to effectively translate the information given into improved health care delivery for all our patients.

CSA 2025 Annual Meeting Anesthesia Abstract Presentation Guidelines

1. Those healthcare professionals and trainees with a focus on anesthesia, pain medicine, maternal or critical care or perioperative medicine are eligible. We encourage physicians in practice and in training, advanced practice providers, medical and graduate students, nurses, and other healthcare practitioners to submit their abstracts.
2. An application, including an abstract of no more than 200 words should be submitted electronically by February 10, 2025, to: <https://form.jotform.com/242827707540055>
3. The papers are submitted with the understanding that they represent recent work performed primarily by the presenter. This does not preclude their presentation in National or International meetings after January 1, 2024, or publication in press in a peer reviewed journal by June 2023.
4. Topics should have a clinical message pertaining to Ambulatory Anesthesia, Chronic and Cancer pain, critical care, Equipment, Monitoring and Engineering technology, Geriatric Anesthesia, Obstetric Anesthesia, Outcome Research, Patient Safety, Pediatric Anesthesia, Regional Anesthesia and Acute Pain. Case reports are welcome.
5. The Annual Meeting's Scientific Committee will select 10 abstracts for oral presentations based on their academic merit, clarity, method of presentation and originality.
6. A disclosure form for any relevant financial relationships will be sent and must be received by all giving an oral presentation.
7. The winner of the abstract session will receive their registration fee to the CSA 2026 Annual Meeting & Workshops provided complimentary. The winner will be notified by email and the prize given out on Saturday at the conclusion of the Oral Session. 50% discount for 2nd place. 25% discount for 3rd place.
8. Presenters should be prepared to provide a printed-out poster or an electronic copy of their poster. Guidelines for which type of abstract presentation the meeting will feature will be given prior to the event.
